



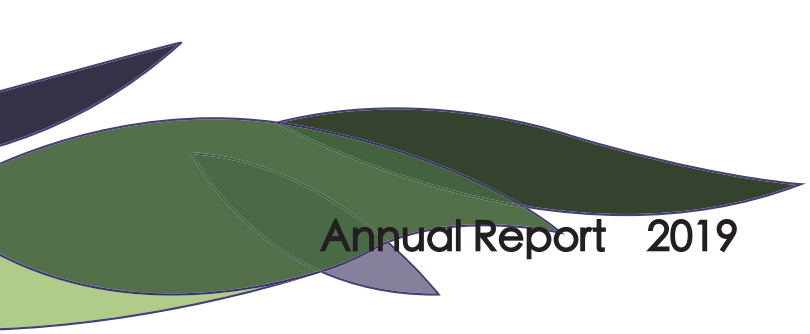

Annual Report 2019

Established with the approval of the Chinese government in 1992, the China Council for International Cooperation on Environment and Development (CCICED) is a high-level non-profit international advisory body. Along with China’s rapid economic and social progress, the Council has witnessed and taken part in the country’s historic shifts in development philosophy and model. The CCICED has played a unique role in championing sustainable development throughout these shifts.

Each of the CCICED phases spans a term of five years. The CCICED Chairperson position is taken by one of the leaders of China’s State Council who is responsible for environmental issues. Currently, the CCICED Chairperson is Mr. Han Zheng, Vice Premier of the State Council. The Ministry of Ecology and Environment of China (MEE) serves as the executing agency of CCICED. The first phase of CCICED (1992–1996) focused primarily on exchanging and spreading international experience and successful policies while also raising the environmental awareness of decision-makers. The second phase of CCICED (1997–2001) focused on environmental pollution problems in China by studying the relations between environment and economic development as well as facilitating the development of laws and regulations on environmental protection. The third phase of CCICED (2002–2006) was committed to incorporating environmental protection into comprehensive decision making for the development of China and exploring how to reach a reciprocal relationship between environment and economic development. The fourth phase (2007–2011) encouraged China to establish a new relationship between economic development and environmental protection. It also explored a new path in which environmental protection optimizes economic development. Aiming to facilitate sustainable development and ecological civilization in China, the fifth phase of CCICED (2012–2016) shifted its policy research focus to the environment and social development issues. The sixth phase of CCICED (2017–2021) aims to serve China’s ecological civilization construction and global sustainable development, and promote the realization of a beautiful China and a green and prosperous world.

Over the past 28 years, with the support of the Chinese government and the cooperation of relevant foreign governments and international organizations, CCICED has been providing policy recommendations to the Chinese government on key environmental and developmental issues. It has done this by inviting internal and external experts and scholars conducting in-depth research, so as to make unique contributions to China’s sustainable development: CCICED has thus attracted significant attention and received the full recognition of all Chinese and international parties. CCICED has opened the door to international experience on sustainable development and built a bridge between China and the international community on environment and development. The CCICED has truly provided a valuable platform of exchange, enabling the international community to understand China and support the country’s engagement with the world.

2019 REVIEW

2019 marks the 70th anniversary of the founding of the People's Republic of China. This is a crucial year for the establishment of a moderately prosperous society. During the reporting period, the Council has carried out the 2019 Work Plan as approved by the executive members under the theme of "A New Era: Towards a New World of Green Prosperity." The aim in this period focused on building an innovative platform for international cooperation on environment and development that embraces global inclusiveness, open cooperation, and mutual benefits and development. The Council has achieved positive progress in areas such as conducting policy research, promoting exchanges and communications, and expanding partnerships.

CCICED continues to be highly valued and supported by the Chinese government. Vice Premier Han Zheng attended the closing session of the CCICED 2019 Annual General Meeting and delivered an important speech with the theme of "Practicing the New Concept of Green Development and Marching Towards a Green and Prosperous New World." He expressed that the Chinese government fully affirms the great efforts made by the CCICED in promoting China's sustainable development and supports CCICED continuing to play an important role.

The active participation of Chinese and international members, special advisors, and experts has played a positive and key role for CCICED in making continuous progress. Nearly 30 council members and special advisors participated in policy research. In particular, the executive vice chairs, vice chairs, and chief advisors personally led the work of task forces and special policy studies. They have guided and organized international and Chinese experts carrying out cutting-edge studies on emergent topics. This has led to great improvements in the quality and level of CCICED policy research.

The policy research findings and policy recommendations of the CCICED continue to receive particular attention from the Chinese government. Many of the recommendations have been reflected at varying levels in the past year's policy practice and exploration. Some forward-looking policy recommendations have important implications for future efforts on ecological civilization construction, with reference provided for effectively playing the role of policy consultation. These include the introduction of the "Opinions on Further Enhancing the Pollution Control of Plastics," the drafting of framework documents for hosting the 15th Conference of the Parties to the Convention on Biological Diversity, the drafting of the law on Yangtze River Protection, and the formulation of the 14th Five-Year Plan and the coordinated response to climate change.

The Ministry of Ecology and Environment further strengthened its leadership and support to the CCICED secretariat,

increasing its personnel and financial support. The number of secretariat staff has nearly doubled. Chinese government agencies such as the Ministry of Foreign Affairs, the National Development and Reform Commission, the Ministry of Industry and Information Technology, the Ministry of Finance, the Ministry of Natural Resources, the Ministry of Transportation, the Ministry of Agriculture and Rural Affairs, the Ministry of Commerce, and the People's Bank of China continue to attach great importance to the work of the CCICED, with support provided in various ways.

CCICED Phase VI continues to receive broad attention and active support from the international community. With active support from Environment and Climate Change Canada, the new International Chief Advisor and the new Secretariat International Support Office commenced their work beginning April 1, 2019. In addition, CCICED has received strong financial support from government agencies from countries including Norway, Germany, Sweden, the Netherlands, and Italy, as well as from institutional supports including the Rockefeller Brothers Fund, the Nature Conservancy, the Environmental Defense Fund, and the Energy Foundation. Supporting international and regional organizations include the United Nations Environment Programme, United Nations Development Programme, the United Nations Industrial Development Organization, the European Union, and the Asian Development Bank. Support also come from think tanks and research institutions such as the World Resources Institute, the International Institute for Sustainable Development, ClientEarth, World Economic Forum, and the World Wide Fund for Nature, as well as renowned enterprises, including the Esquel Group and WalMart Inc. All of these supporting agencies have contributed to CCICED's work by participating in the research, jointly organizing events, and providing capacity-building training as well as financial and intellectual support.

In addition to those listed above, many other think tanks, universities, and research institutions have pledged support to CCICED through expert consultations, supporting capacity-building activities, and disseminating and sharing outputs at home and abroad. These are all important building blocks for the long-term development of CCICED.



2019 Annual General Meeting

2019 Annual General Meeting



Combined with the World Environment Day celebrations, CCICED 2019 AGM, themed “A New Era: Towards a New World of Green Prosperity,” was held from June 2 to 4 in Hangzhou city, Zhejiang Province. The theme of the World Environment Day celebrations was “Beat Air Pollution,” which focused on air pollution prevention and control, and shared the approaches and achievements of China’s ecological civilization construction and air pollution treatment with the international community.

Chinese President Xi Jinping sent a congratulatory letter to the World Environment Day celebrations and Mr. Han Zheng, Vice Premier of the State Council, read the letter and delivered an important speech. Mr. António Guterres, UN Secretary-General, also sent a congratulatory letter to the celebrations, which was announced by Ms. Joyce Msuya, Then Acting Executive Director of UN Environment. CCICED Chairperson Han Zheng attended the AGM closing ceremony and listened to the policy recommendations in person.

The AGM and the celebrations were attended by more than 1,100 delegates from 25 countries, including UN Then Secretary-General Ban Ki-moon, council members and special advisors, partners and government officials, representatives from UN Environment, the United Nations Industrial Development Organization (UNIDO), and Secretariat of the Convention on Biological Diversity (CBD), as well as other distinguished guests from Australia, Germany, India, Italy, Japan, Korea, Russia, and the United Kingdom.



Major Effects

1.1 Highlighting the strategic and forward-looking role of CCICED. With a special emphasis on the 14th Five-Year Plan (FYP), this AGM centred on “Reaching New Consensus on Green Development: the Pathway to China’s High-Quality Development during the 14th Five-Year Plan Period,” and put forward policy recommendations to the Chinese government after extensive discussion. This AGM was marked as the highest-level international meeting in 2019 in terms of the scope of experts engaged in policy recommendations to the 14th FYP.

1.2 Highlighting the direct channel for CCICED policy recommendations to Chinese leadership. Vice Premier Han Zheng listened to the policy recommendations from CCICED vice chairpersons and nine council members in person, spoke highly of the important role that CCICED has played over the past years, reflecting China’s firm commitment to implement green development and positive attitude in promoting ecological civilization with the world.

1.3 Highlighting CCICED’s role as a two-way communication platform. Open forums on Post-Katowice Global Climate Governance, CBD COP15, green BRI and other multilateral issues were held, and consensus was reached through candid dialogue. Participants showed full recognition of the concept of ecological civilization in promoting sustainable development, and high appreciation for the role of CCICED in sharing and showcasing advanced theories and best practices of sustainable development.

High-Level Events



(I) The Panel Session of Greening China's Belt and Road Initiative of Summer Davos 2019

The Annual Meeting of New Champions 2019 (Summer Davos 2019) of the World Economic Forum (WEF) was held from July 1 to 3, 2019 in Dalian, China. With support from the CCICED secretariat, WEF hosted a Panel Session on “Greening China's Belt and Road Initiative.” Mr. Zhao Yingmin, CCICED Secretary-General and Vice Minister of Ministry of Ecology and Environment of China (MEE) attended the session and outlined the progress achieved in building a green Belt and Road Initiative (BRI) and the outcomes of CCICED-funded policy research.

It was agreed by the delegates that realizing green and sustainable development holds the key to solving major global issues. A green BRI provides a vital pathway for participating countries to attain sustainable development. Building a green BRI is not only significant but also a necessity. Achieving it requires concerted efforts from all stakeholders, joint action to practice the philosophy that “lucid water and lush mountains are invaluable assets,” and a vision of an ecological civilization, as well as effective realization of the 2030 Agenda for Sustainable Development.



(II) Round Table Meeting on Collaborative Governance on Climate and the UN 2030 Agenda for Sustainable Development

CCICED and BRI International Green Development Coalition (BRIGC) jointly held a round table meeting in New York City, United States on September 24, 2019. Mr. Xie Zhenhua, CCICED Vice Chairperson and Special Envoy for Climate Affairs of China, delivered opening remarks. Mr. Vidar Helgesen, CCICED Vice Chairperson and Norway's Special Envoy to the High-Level Panel on Building a Sustainable Ocean Economy and Mr. Erik Solheim, CCICED Vice Chairperson and Advisor of World Resources Institute (WRI) attended the round table and made leading remarks. The meeting attracted over 150 delegates, including CCICED members and special advisors, representatives from CCICED partners, as well as scholars and experts.

With the theme of “Collaborative Governance on Climate and the UN 2030 Agenda for Sustainable Development,” the round table meeting focused on the achievements of and measures for collaborative governance for addressing climate change, improving air quality, and conserving biodiversity. It explored the paths of green development toward the 2030 Agenda for Sustainable Development, particularly how to closely link these paths to significant international public goods such as the BRI.

(III) Side Event on “Greening the Blue Road: Promoting Marine Environment Governance in the Belt and Road Initiative” at Our Ocean 2019

On October 23, 2019, during the “Our Ocean 2019” conference, CCICED held a side event titled “Greening the Blue Road: Promoting Marine Environment Governance in the Belt and Road Initiative” in Oslo, Norway to discuss the governance of the marine environment and green BRI.

The side event was chaired by Mr. Vidar Helgesen, CCICED Vice Chairperson and Norway’s Special Envoy to the High-level Panel on Building a Sustainable Ocean Economy. Mr. Eric Solheim, CCICED Vice Chairperson and Advisor of World Resource Institute, and Mr. Marco Lambertini, CCICED Member and Director General of WWF International, attended the side event and delivered speeches. As emphasized in the event, the ocean plays a vital role in realizing sustainable development. A central point was the importance of enhancing international cooperation on ocean environmental governance and jointly building green BRI by broadening its partnership network.

More than 60 delegates participated in the event, representing government agencies, private sector, NGOs, and research institutions.



(IV) High-Level Dialogue on the Role of Ocean in Addressing Climate Change

CCICED hosted the High-level Dialogue on the Role of Ocean in Addressing Climate Change on October 30, 2019, in Beijing, China to discuss the role of the ocean in mitigating climate change.

Mr. Vidar Helgesen, CCICED Vice Chairperson and Norway’s Special Envoy to the High-level Panel on Building a Sustainable Ocean Economy, attended the dialogue. A report by the High-Level Panel for a Sustainable Ocean Economy—The Ocean as a Solution for Climate Change: 5 Opportunities for Action—formed a helpful basis for discussion. The report outlines the role and potential contributions of the ocean to renewable energy, maritime transportation, coastal and marine ecosystems, marine fishing, aquaculture, and diet shift, as well as seabed carbon storage.

The dialogue attracted over 30 representatives from several research institutions to the venue. A number of experts joined the dialogue through video.

(V) The CCICED Round Table Meeting 2019 and the Belt and Road Green Innovation Conference

The CCICED Roundtable Meeting 2019 and the Belt and Road Green Innovation Conference took place in Shenzhen, China, on December 3, 2019. CCICED Secretary-General and Vice Minister of MEE Mr. Zhao Yingmin attended the event and delivered an opening speech.

As reiterated in the event, green innovation is a core driving force for high-quality development while green BRI development provides innovative solutions to challenges in global sustainable development. It is necessary to seize the opportunity for innovation brought by the new round of scientific and industrial revolution, and facilitate the realization of high-quality development and high-quality eco-environmental protection.

More than 200 delegates participated in the event, including Mr. Erik Solheim, CCICED Vice Chairperson and Advisor of World Resources Institute, Mr. Liu Shijin, Chinese Chief Advisor of CCICED and Deputy Director of the Economic Committee of the Chinese People's Political Consultative Conference (CPPCC), Mr. Scott Vaughan, International Chief Advisor of CCICED, as well as representatives from CCICED partners.

Policy Research

Phase VI of CCICED has established four research task forces on the topics of “Global Environmental Governance and Ecological Civilization” “Green Urbanization and Environmental Improvement” “Innovation, Sustainable Production and Consumption” and “Green Energy, Investment and Trade” respectively. These four task forces serve as a framework under which sector-specific research projects will gradually be launched. As the policy research work advances, this scientific and systematic approach has been recognized and welcomed by the council members, special advisors, and partners. In the past few months, each of the Special Policy Study (SPS) teams has proposed policy recommendations focusing on China's 14th FYP, as well as on major global environmental topics, such as climate change and biodiversity.

Serve Major National Strategic Priorities Reflecting Domestic Policy Demand

1. A Beautiful China in 2035

The SPS on Goals and Pathways for Environmental Improvement in 2035 convened several workshops. With a focus on the 14th FYP, the SPS proposed relevant policy recommendations such as establishing an indicator system and demonstration zones for building a beautiful China; mobilizing business leadership; strengthening environmental governance; and promoting the sustainable management of chemicals.

2. Regional Integrated Development

The SPS on Green Urbanization Strategy and Pathways Towards Regional Integrated Development identified the primary tasks for China's green urbanization, researched the basic features of the consequences of traditional urbanization, analyzed patterns for China's future urbanization, and proposed policy recommendations on the strategic options for China's green urbanization.

3. Conservation of the Yangtze River

The SPS on Ecological Compensation, Green Development and Institutional Reform in the Yangtze River Economic Belt convened an international workshop on ecological compensation. With a focus on the 14th FYP, the SPS proposed relevant policy recommendations such as the medium- to long-term ecological and environmental protection strategy for the Yangtze River Economic Belt, calculation of natural capital, an omnidirectional and multiscale mechanism on ecological compensation, legislation on conservation of the Yangtze River, and the establishment of environment protection platforms.

4. Green Consumption

Looking at consumption's impact on resources and environment, the SPS on Green Transition and Sustainable Social Governance analyzed the working mechanism of China's green consumption and green socioeconomic transformation. The SPS also reviewed China's current policy practice on green consumption and proposed strategic positioning and policy recommendations to the Chinese government on promoting green consumption.

Serve the Global Environmental Governance with a Focus on the Emergent International Topics on Environment and Development

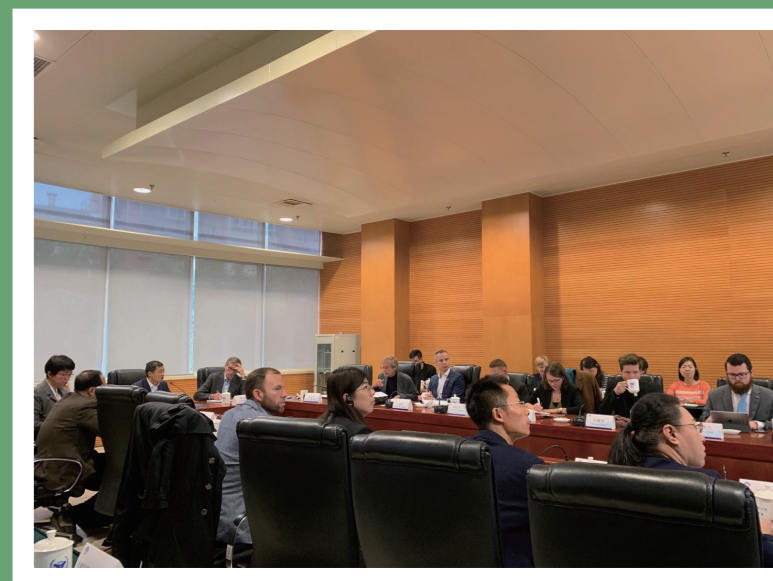
1. Global Climate Governance

The SPS on Global Climate Governance and China's Role carried out research on the opportunities and challenges facing climate adaptation work in the context of ecological civilization and green development. The SPS also looked at China's roles in, contributions to, and leadership in global climate governance. The SPS proposed policy recommendations on China's climate policy during the 14th FYP, strengthening the government's climate leadership, and promoting low-carbon development along the Belt and Road region.

2. Biological Diversity

The SPS on Post-2020 Global Biodiversity Conservation focused on analyzing the construction of a nature reserve system in China that is mainly based on national parks. The SPS summarized the experience and progress of biodiversity

conservation and proposed policy recommendations on the framework, objectives, ways, and means for post-2020 biodiversity conservation.

3. Ocean Governance

The SPS on Global Ocean Governance and Ecological Civilization completed two thematic studies on marine pollution and green shipping. The SPS focused on analyzing the sources and channels of land-based marine pollution and provided preliminary policy recommendations on marine pollution prevention and control, green shipping management, and ecosystem-based integrated marine and coastal management.

4. Green Belt and Road Initiative

The SPS on the Green BRI and the 2030 Agenda for Sustainable Development researched and identified mechanisms and pathways to realize a green BRI while advancing the Sustainable Development Goals (SDGs). The SPS proposed policy recommendations for the pathways and long-term and effective mechanisms to develop the green BRI.

Launch Three New Special Policy Studies

1. Major Green Technology Innovation and Implementation

Leveraging CCICED's global network, this SPS will categorize the major green industry technologies that need to be promoted, with a focus on innovative technologies relating to green urbanization, such as urban infrastructure, energy, transportation, and architecture. The SPS will study the implementation and institution mechanism and promote waste-free cities.

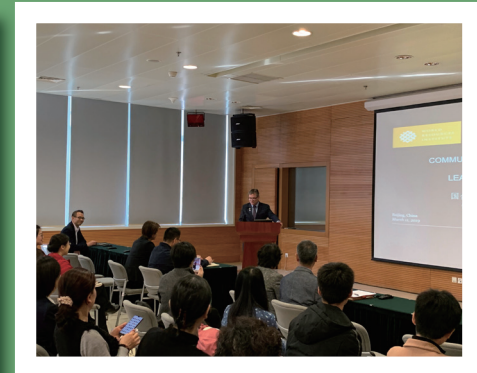
2. Global Green Value Chain

This SPS will launch research on the circular economy and green value chain at the global level; review relevant bilateral, plurilateral and regional trade agreements; and promote green and sustainable global trade.

3. Green Finance

This SPS will launch the forward-looking research around financial policies and measures related to ecological protection. The SPS will also explore the possibility of promoting of China's green finance innovation practices at international level, and the application of international experience in China.

Publicity and Communication



1. Played the Role of Two-way Communication Platform and Promoted International Dialogue and Exchanges.

With the support of partners, and in conjunction with relevant SPS work, CCICED organized thematic workshops at locations around the world—including Egypt, Germany, Kenya, the Netherlands, Pakistan, Sri Lanka, Sweden, and the United Kingdom—on a range of topics, including the green BRI, climate change adaptation, biodiversity conservation, ocean governance, sustainable consumption, and green urbanization. By embracing the latest international experience and practice into CCICED research outputs, these workshops have enabled the dissemination of China's most recent policies on environment and development as well as CCICED's research progress to our partners. In addition, the Council convened regular meetings for chief advisor-secretariat joint work, as well as with donors and partners, where it promptly shared CCICED's work progress and exchanged views on important matters.

2. Strengthened Capacity Building on Communications Cooperation Framework Agreements

Executed the International Communication Cooperation Framework Agreements. The Council has established long-term strategic cooperation relationships with China Daily and The International Institute for Sustainable Development (IISD) to assist CCICED in event reporting and policy research progress updates. These relationships will also enable the sharing of China's green development practices and strengthen CCICED's international communications capacity.

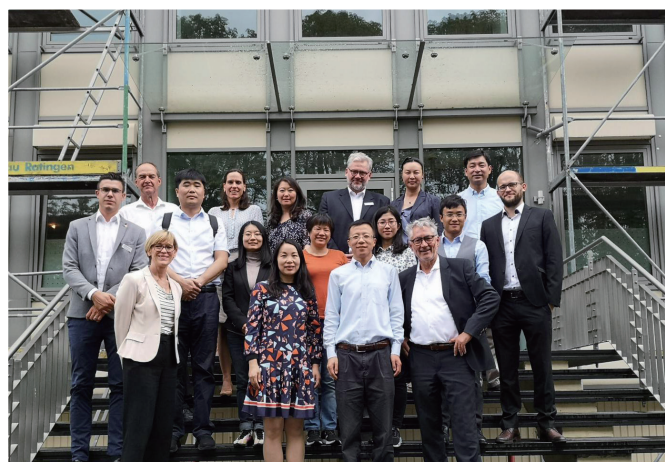
Carried Out Communications Strategy Training. The secretariat participated in communications strategy trainings delivered by partners including the World Resources Institute (WRI). The training laid a solid foundation for improving CCICED's communication capacity in developing an open and inclusive international cooperation platform.

3. Utilized Multimedia Platforms and Widely Disseminated CCICED Information

During the 2019 AGM, a total of 19 articles were published in China Daily and its global edition. China Daily also posted 21 articles and four videos on its website. The videos were also shared via nine Chinese and international platforms, including Facebook, Twitter, and YouTube, with more than 2.37 million views in total. IISD sent professional reporters to cover the AGM and produced seven in-depth reports, shared with 64,000 professionals. In the meantime, the CCICED secretariat sent out 40 issues of weekly newsletters to update the progress of achievements and results.

Through various media outlets (including the CCICED website and WeChat official account), the Council has published timely information on CCICED updates, research outputs, policy progress, and innovative technologies relevant to environment and development in China and internationally. The CCICED research outputs were widely disseminated in multiple formats, such as graphics, and videos, which resulted in a broadened viewing audience and expanded CCICED influence.

Operation and Management



1. Smooth Operation of the Secretariat

Through the solid leadership of the executive members, with the active participation of council members and special advisors along with strong support from partners, the secretariat has managed to ensure the successful completion of all the planned activities and has delivered results as targeted.

- Coordinated CCICED policy research activities, and provided all-round support to the establishment and work of the SPS teams. The secretariat has organized and participated in over 50 SPS meetings and events which ensured continuous progress of the research work.
- Strengthened contact with council members and special advisors, inviting them to attend CCICED events and providing support accordingly.
- Expanded CCICED partnerships, having added nine international council members and five special advisors, gaining more support and contribution from countries, international organizations, and enterprises.
- Organized major events, including the AGM and the round table meetings, continuously improving organizational skills.
- Enhanced capacity building for the secretariat through training sessions in China and overseas to improve its overall management capacity.

2. Increasing Significance of the Chief Advisors and Their Supporting Teams

With great support from Environment and Climate Change Canada, the past year witnessed a smooth transition of the CCICED International Chief Advisor to Mr. Scott Vaughan. The chief advisors, in close collaboration with their supporting teams, have been providing full support to the policy research work this year, including: consultative advice to the Secretary-General regarding the task forces and SPS; academic guidance to the policy research teams to ensure effective communication; drafting of policy recommendation of the 2019 AGM to the State Council (draft), Issues Paper, and Progress on Environment and Development Policies in China and Impact of CCICED's Policy Recommendations, all of which laid a solid foundation for a successful AGM; keeping close contact with their supporting teams and the secretariat to ensure all work proceeded smoothly.

3. Important Role of the Secretariat International Support Office

IISD has begun work as the new Secretariat International Support Office (SISO) starting in April 2019.

SISO has been actively promoting CCICED's outcomes by compiling over 40 issues of the CCICED Weekly newsletter to share CCICED's research outputs and work progress with council members and partners; implementing the CCICED Guidelines on Gender Equality and promoting the mainstreaming of gender equality into the operations and research work of CCICED; playing an important role in coordination and communication with international experts, fund management, and expansion of partnerships.

Fund Management

Financial support from the Chinese government and international partners for Phase VI is about USD 23 million.

The funds were divided into a core fund and funds for specified use. The core fund can be used flexibly for various activities, including the AGM, policy research, the Round Table Meeting, the work of chief advisors and the secretariat. Moreover, the funds can also be used for emergent responses to changes in work focus and situations. The core fund accounts for about 80% of the total. The fund for specified use is provided for specific activities, normally to support specific task forces, policy research, or demonstrative projects. This part of the fund accounts for about 20% of the total.

Most of the funds are managed by the secretariat and SISO. SISO is responsible for the management of endowments from Canada, and part of the funds that the Norwegian government provides. Funds administered by SISO represent about 30% of the total amount. Under certain circumstances, the donors' offices may manage their own endowments.

In 2019, the secretariat and SISO continued to implement the fund-management guidelines for relevant expenditures of task forces. These guidelines are based on the rules and restricted provisions established by the Chinese government and major donors of CCICED. It identifies expenditure standards and reimbursement procedures, and ensures as much as possible that all task forces are subject to the same standards. Meanwhile, relevant fund-management procedures, contracts, and file templates are made to facilitate task force fund management.

Up to December 2019, the expenditure of CCICED Phase VI totaled USD 14,620,000. Expenditures in the 2019 fiscal year are listed as follows: USD 1,767,641 for policy research, USD 646,327 for the AGM and the Round Table Meeting, USD 416,446 for the chief advisors, USD 1,057,554 for the secretariat and publicity, and USD 369,873 for SISO and training.

The SISO 2019 fiscal year runs from April 2019 to March 2020.

Major Work Plan for 2020

2020 will be a period for the further implementation of Phase VI of CCICED. Under the leadership of the Executive Members, under the guidance of the council members and special advisors and support from council partners, through policy research, events, and other activities, CCICED is also committed to contributing to the high-quality development of China and to actively engaging in the international environmental governance process.

2.Strengthening Team Building for the Chief Advisors

The Council plans to further optimize the supporting teams for Chinese and international chief advisors to support their work by enriching the research background.

3.Enhancing Capacity Building for the Secretariat

The Council plans to strengthen the secretariat's capacity building, in particular, the capacity on research planning and strategizing. The Council will coordinate and collaborate with the SISO so all work can be carried out and supported in a continuous and effective manner.

4.Expanding the Communications Network, Innovating Communications Channels, and Disseminating Research Outputs to the Global Community

The Council plans to continue deepening its cooperation with partner institutions such as China Daily and IISD. The Council will disseminate the research outputs with the international community. In addition to the website and WeChat, the Council plans to enhance dissemination efforts and to increase interaction by utilizing cross-platform publishing on social media platforms such as Weibo, Facebook, and Twitter. The Council will continue publishing the bilingual CCICED Annual Policy Report. The Council also plans to publish collections on selected policy research work.
