

CCICED 2021 Annual General Meeting

COVID-19 Precautions and Considerations

Dear Participants,

The China Council for International Cooperation on Environment and Development (CCICED) 2021 AGM will be held in a hybrid format on September 7 to 10. The on-site venue is Beijing Hotel. In order to prepare for the prevention and control of COVID-19 during the AGM, **participants located outside of Beijing will not be invited to participate on-site in the conference** according to the requirements of epidemic prevention in Beijing. The requirements for in-person participants in Beijing are as follows:

1. Delegates participating in the Closing Session of the AGM on September 9 must enter the venue with their Meeting badges and **a negative nucleic acid test certification within 48 hours before the closing ceremony (8:00 pm)**. Nucleic acid testing will be arranged for Closing Session participants on the second floor of Building A, Beijing Hotel from 11:30 to 15:00 on September 8. Participants who cannot take test during the mentioned hours should complete the nucleic acid test by themselves within the required time.
2. During all sessions of the AGM, all participants must wear facial masks at all times. Prior to entering the venue, participants shall cooperate with the security personnel to take temperature measurements and to present the Health Kit codes. Only those within normal values will be admitted to the meeting venue. Before and during the meeting, and strictly maintain social distance (above 1 meter) with other

participants.

3. It is highly recommended that participants minimize their physical activities throughout the venue; If coughing and sneezing occurs in the venue, participants should cover their mouth and nose with tissues and/or bend elbow to prevent the spread of droplets;
4. Before the meeting and during the meeting, avoid non-essential outside contact; Wash hands frequently.
5. Participants should not be asymptomatic persons who have recovered and have left the centralized isolation, or infected persons who are still under treatment and medical observation; There should be no record of direct and/or sub-close contacts with persons mentioned above. In the 14 days prior to the closing ceremony of the AGM, there should be no record of residence, stay, or contact with people infected with the COVID-19 (confirmed and asymptomatic cases), contact with suspected cases, secondary contacts with infected persons, and/or have contact with people with travel or residence history in high-risk regions.
6. Vaccination is required for participation in the AGM; all participants should be fully vaccinated, and those who have not been vaccinated will **not** be permitted to participate in on-site AGM activities. Participants should have no symptoms of fever, fatigue, cough, sore throat, diarrhea, vomiting, decreased sense of smell or taste in the 14 days prior to the closing ceremony of AGM.
7. When participants are diagnosed with suspected or confirmed cases of COVID-19

within 14 days after the AGM, they should inform the CCICED Secretariat immediately.
