• 2011 Workplan of CCICED

2011 is the last year of CCICED Phase IV (2007-2011). Apart from completing the approved Policy Research Programmes to be reported to the 2011 Annual General Meeting (AGM) of CCICED, establishing new Policy Research Programmes for 2012, CCICED will also start the preparation for Phase V (2012-2016).

The Workplan for 2011 approved by the Bureau Meeting on November 10, 2010 is as follows:

I. Policy Research Activities

1. The Policy Studies reported to the 2011 AGM

> Task Forces already established

As approved by the 2009 Bureau Meeting, the following three Task Forces officially started their activities in 2010. The Chinese and international team will continue their joint work and report the findings and recommendations to CCICED 2011 AGM.

i. Task Force on Low Carbon Industrialization Strategy in China (2010—2011);

ii. Task Force on Development Mechanism and Policy Innovation of China's Green Economy (2010—2011);

iii. Task Force on Investment, Trade and Environment (2010—2011).

New Policy Studies to be set up

In compliance with his functions, the Secretary General will approve some small policy studies with the support of the Secretariat and the Chief Advisors when appropriate. The possible studies may include the Special Policy Study on Green Supply Chain and the Special Policy Study on Mercury Management, etc. 2. Policy studies to be reported to the 2012 AGM

i. Task Force on Policy Mechanisms for Meeting "12th Five-Year Plan" Environment and Development Objectives (2011-2012);

ii. Task Force on Strategy and Policies on Environment and Development in Western China (2011-2012).

3. Other Programmes

The Bureau Meeting of CCICED 2008 AGM approved the establishment of China Environment and Development Outlook Program. The Program was established in 2010 and officially started research work. The international and Chinese experts will work jointly to conduct the study and submit the report to the 2011 AGM. The compilation of the report is subject to the Bureau Meeting of 2011 AGM.

II. CCICED 2011 AGM and the 20th Anniversary Forum of CCICED

The CCICED 2011 AGM and the 20th Anniversary Forum of CCICED will be held in Beijing on November 15-17, 2011. The 2011 AGM will be held on 15-16 (excludes the Bureau Meeting), while the 20th Anniversary Forum to be held on November 17.

The AGM will review the policy study reports and put forward Policy Recommendations to the Chinese Government. The theme of the AGM is suggested to be "Economic Development Mode: Green Transformation".

The 20th Anniversary Forum will review and share the achievements and Policy Recommendations submitted by CCICED so far, and look into the international and Chinese trends of environmental protection and development as well as the long term development of CCICED. Dialogues and discussions on related policies will be conducted. The international and Chinese members from Phase I to IV will be invited as well as the representatives and experts from government departments concerned.

III. Preparation for CCICED Phase V

CCICED Phase IV will be ended in 2011 and Phase V will start in 2012. Preparation work is one of the key works of 2011, which includes the following: develop rules and regulations; identify overall policy study directions and key areas; go through a series of review and approval procedures; raise and put in place operational funds, including financial support both from the Chinese Government and the international side.

IV. Other arrangements

The Secretariat will enhance the close communication and cooperation with the Chief Advisors, the international and Chinese partners under the leadership of the Secretary General, focusing on the following : i. To hold and attend policy study workshops in different scales and levels in China to strengthen the communication with relevant departments of central and local governments to further disseminate and implement the Policy Recommendations;

ii. To consider to hold workshops abroad in proper scale and form to introduce the work of CCICED to expand CCICED's influences internationally when appropriate, and to develop and extend its partnerships;

iii. Continue to strengthen and promote the publicity work and disseminate the progress and results of CCICED by means of publications, internet and CCICED website. Special attention should be given to maintain closer communicate and contact with the international and Chinese members as well as experts;

iv. To take the opportunity of celebrating 20th Anniversary of CCICED to widely extend CCICED's social impact and share CCICED's achievements of the past 20 years through a variety of publications, exhibitions, workshops and events.
