Premier Wen Jiabao chaired the executive meeting of the State Council on September 19, 2012, listened to the work report on "grain for green", discussed and approved the Project Plan Phase II for the Control of the Sand and Dust Sources for Beijing and Tianjin Area (2013-2022) and decided to establish the "National Low Carbon Day".

The meeting pointed out that the implementation of the "Grain for Green Program" was a major decision of the CCCPC and the State Council to improve the eco environment at the beginning of this century. Relevant department shall identify the focus, continuously implement the program, and further consolidates the achievements of the program.

The meeting discussed and approved the Project Plan Phase II for the Control of the Sand and Dust Sources for Beijing and Tianjin Area (2013-2022). In order to further reduce the sand & dust in Beijing and Tianjin area, continuously improve the capacity of this area for the sustainable economic and social development and develop eco shield for the North China, the meeting decided to implement the Phase II based on the achievements of the Phase I.

To disseminate the know-how of climate change, spread the concept and policy of low

carbon development, encourage the public participation and promote the implementation of the emission reduction tasks of GHGs, the meeting decided that the third day of the Energy Conservation Publicity Week in June each year will be set as the "National Low Carbon Day" from 2013. Li Keqiang meets with Chairman of the United Nations Climate Change Doha Conference in Beijing

Vice Premier Li Keqiang met with Mr. Abdullah bin Hamad al-Attiyah, Chairman of the United Nations Climate Change Doha Conference in Beijing on September 17, 2012.

Li Keqiang said, it requires the joint efforts of the international community to address the climate change. Each country shall encourage the restructuring so that to establish energy-efficiency, an environment-friendly and low-carbon economy in their effort to promote the economic recovery. Meanwhile, we shall adhere to the principle and regulations of UNFCCC in particular the equity principle the principle of "common but differentiated responsibility", fully take into consideration of the development stage and the future development room of the developing countries and prioritize the implementation of the consensus that have been reached. The United Nations Climate Change Doha Conference will be held in a few months. It is hoped that Qatar as the host country could play an active role to push forward the Bali Roadmap negotiation and achieve substantial results, and urge the developed countries to assume substantial reduction targets and fulfill their commitments to provide funds and transfer technology.

Mr. Abdullah bin Hamad al-Attiyah expressed his willingness to strengthen the communication and coordination with the Chinese side, and enhance the joint efforts of all parties to address the climate change. On Sep. 26, 2012, MEP Minister Zhou Shengxian met with the visiting Danish Environmental Minister Ms. Auken in Beijing. They exchanged viewpoints on a set ranging from of topics China's environmental policy, China-Denmark environment cooperation in general and the cooperation within the framework CCICED, and the follow-ups of Rio+20. They agreed to strengthen cooperation in fields as the prevention and control of water pollution, mercury pollution and chemical management.

Zhou noted that China and Denmark have maintained good cooperation environment protection in the past years. Danish Environment Many successive Ministers visited China. The cooperation is very fruitful. The two Ministries renewed the cooperation agreement on environmental protection in 2007. Li Ganjie attends the International Forum on Biodiversity and Green Development

CCICED Secretary General and MEP Vice Minister Li Ganjie addressed the International Forum on Biodiversity and Green Development on September 13, 2012 in Beijing..

Li Ganjie pointed out that promoting the biodiversity conservation and achieving green development is an integral part of the exploration to a new path towards environmental protection with the aim to seek green development of biodiversity -friendly. This kind of green development must follow the law of nature, bring into full play of the multiple functions of the biodiversity in providing ecological products services. speed up the transformation both social and economical. and realize all-win situation from the perspective of economic, social ecological benefits at community, national and global level.

Li stated that the Chinese government attaches great importance to biodiversity conservation. In June 2011, the State Council established China National Committee on **Biodiversity Conservation to coordinate the** biodiversity conservation at the national level and guide the implementation of China's Action Plan to Enforce Biodiversity 2011-2020 Strategic Plan. The legal system for biodiversity conservation has basically established and a set of major plans and programs including the China's Strategy and Action Plan for Biodiversity Conservation have been developed and implemented. We have gradually improved the coordination mechanism for biodiversity conservation and the effect of in situ and ex situ conservation was remarkable. International cooperation on biodiversity conservation also advanced vigorously.

Li Ganjie stressed that green development is the latest efforts of human kind to address the challenges from the economic crisis. environment and resource crisis ecological crisis. It is the harmonized coexistence of man and nature, environment and economical development, and human being and the society, and the sustainable development of low cost, good benefit and low emissions. Biodiversity conservation is the basis for achieving green development. A green development of biodiversity-friendly pattern shall be worked out to conserve biodiversity on the one hand and to improve the economic efficiency and promote the equity on the other mainstreamed biodiversity conservation activities, extensive international cooperation and effective actions. Secretary General of CCICED and MEP Vice Minister Li Ganjie addressed the China—ASEAN Environmental Cooperation Forum held on September 17-18, 2012.

In his speech, Li Gnajie pointed out that this Forum, themed "Biodiversity and Regional Green Development", is of profound and far reaching significance to establish partnership in the ASEAN region via policy dialogue and experience sharing, improve the biodiversity conservation via joint efforts and achieve regional green development.

Li Ganjie said the Chinese Government attaches great importance to biodiversity conservation, vigorously encourages the construction of ecological civilization, and carried out biodiversity conservation activities across the country of all round and at all levels with remarkable achievements. China actively joined in the development of

international conventions including Bio-Safety Protocol and Nagoya Protocol, seriously enforced the Convention on Biological Diversity, and carried out a series and diversified cooperation with UNEP, UNDP, EU, GEF and other international institutions and partners. The cooperation has achieved practical results which were highly recognized by all parties and made active contributions to the biodiversity conservation in China.

Li Ganjie presented the following three suggestions to improve the China-ASEAN environmental cooperation: 1) Actively put into effect the initiatives proposed by the leaders, seriously implement the China **—ASEAN Environmental** Cooperation Strategy and bring the two sides forward to achieve new results in the field of environmental cooperation; 2) Continuously enrich the form and contents of the cooperation, actively explore innovative modes improve the South-South to cooperation and make positive contributions to the regional green development; 3) Strengthen personal exchange, experience sharing and research cooperation between the two sides in the field of biodiversity. MEP Announces Reduction of Major Pollutants in 2011 across China

On September 7, 2012, MEP announced to the media the calculation and verification results of the total pollution reduction of major pollutants in 2011 of all provinces, autonomous regions, municipalities and the 8 state-owned enterprises. The results showed that the total discharge of COD, ammonia nitrogen and SO2 emission of the whole country went down and the total NOx emission went up compared to that of 2010.

MEP examined and checked the total discharge of major pollutants for each province, autonomous region and municipality as well as the 8 state-owned enterprises in 2011. The results showed that in 2011 in the perspective of the whole nation, the total COD discharge was 24.999 million t,

down by 2.04% compared with that of 2010; the total NH3 emission was 2.604 million t, down by 1.52% compared with that of 2010; the total SO2 emission was 22.179 million t, down by 2.21% compared with that of 2010; the total NOx emission was 24.043 million t, up by 5.74% compared with that of 2010.

MEP praised Beijing, Shanghai, Zhejiang and Henan for that they lead the top 4 in terms of total pollutant emission reduction. Beijing's total discharge of COD, ammonia nitrogen, SO2 and NOx went down by 3.53%, 2.98%, 6.22% and 4.75% respectively compared with that of 2010. Shanghai's total discharge of COD, ammonia nitrogen, SO2 and NOx went down by 6.26%, 3.40%, 5.90% and 1.66% respectively compared with that of 2010.

In 2011, the country newly added 11 million tons of capacity of urban sewage treatment and increased 1.3 million tons of daily capacity in terms of the reuse of recycled water. The auto monitoring system established during the 11th Five-Year Plan period has been put fully into operation. Over 95% desulphurization facilities have been put into operation. The comprehensive desulphurization efficiency of thermal power plants has gone up from 68.7% to 73.2%. A total of 3.46 million kW capacity of small thermal power generating units have been shut down. Outdated production capacity including 7000 m2 sintering machine, 7.1 million t of papermaking, 2.3 billion meters of printing and dyeing and 42 million t of cement production has been phased out. A group of companies or production lines concerning heavy metal pollution were also shut down. (Source: www.gov.cn)

MEP plans to Establish National Environmental Account to Control Pollution Discharges from New Projects

It is reported on Sep. 26, 2012 that MEP will learn from the Ministry of Land and Resources on its management pattern of land indicators to introduce a system of national environmental account which is comparable to "indicator for advanced increment" under the category of "indicator for newly added land for construction". This will enable better connection between MEP and local governments in terms of approval of new projects. The policy will be executed nationwide in 2016.

The so called "environmental account" is dismantle and calculate, accordingly the three binding targets of **Total Pollution Discharges, Total Reductions** and Advanced Increment of Discharges to governments of all levels. related departments and key polluting companies. These targets apply to four major pollutants including COD, SO2, NH3 and NOx. This will enable the quantifiable management of invisible environmental resources. (Sources: **Economic Information**)

The Inception Meeting of the CCICED Task Force on China's Environmental

Protection and Social Development was held in Beijing on September 18, 2012. MEP Vice Minister and CCICED Secretary General Li Ganjie addressed the meeting. Deputy DG of MEP Department of Human Resources Management and Institutional Affairs and CCICED Assistant Secretary General Ren Yong chaired the meeting. More than 90

people including Vice Minister of the State Council Research Office Ning Jizhe. CCICED International Chief Advisor Mr. Hanson, Academician of Chinese Academy of Engineering Hao Jiming, DG of MEP Department of International Cooperation and CCICED Vice Secretary General Tang Dingding, Deputy DG of MEP FECO and **CCICED Assistant Secretary General Fang** Li. experts of the Task Force from both domestic and international, leaders and experts of relevant departments of the State Council, CCICED international partners and representatives of the embassies of foreign countries attended the meeting.

In his speech, Li Ganjie pointed out that China is in a critical period for the transformation of economic and social development. Economic growth, social development and environmental protection are interdependent. The study on any of the above three areas must consider the influences on and connections with the other two. Therefore, the theme of "the Task Force on Environmental Protection and Social Development" concerns the big picture of China's sustainable development and is a key subject of national strategic importance.

Li Ganjie put forward three suggestions for the Task Force: First, stand at the cutting edge of theoretical study and make achievements of international standard. Second, carry out comprehensive study taking into consideration of both the present and the future. Third, pay attention to the combination of theory with practice that can turn the research into practical results.

The **Task** Force on China's Environmental **Protection** Social and Development was established upon the approval of CCICED 2011 Bureau Meeting. The aim of the Task Force is to put forward thinking and institutional the overall for China's environmental framework protection and social development through theoretical study and international experience and make preparations for the future study of CCICED on the topics concerning the environment and social development. The Task Force will report its research findings at CCICED 2013 AGM.

The State Council Research Office will lead the implementation of the Task Force from the Chinese side. Mr. Fan Bi, DDG of the General Department of the State Council Research Office will serve as the Chinese Co-chair and Ms. Elizabeth Dowdeswell, Chairperson of Canadian Academic Committee and former Executive Director of UNEP will serve as the International Co-chair.

According to the 2012 agenda of the Council, CCICED Task Force on Sustainable Consumption and Green Development shall commence its research work in 2012 and make final report with policy recommendations available to the 2013 AGM.
